

PHOTO CONTEST RULES

PIROI: 20 YEARS OF COOPERATION

The « PIROI: 20 years of cooperation », hereinafter referred to as "the contest", is organized by the Indian Ocean Regional Intervention Platform, hereinafter referred to as "the organizers".

ART. 1. PRESENTATION OF THE COMPETITION

1.1 Themes

This year's theme is « **PIROI : 20 years of cooperation** ».

Participants are asked to interpret this theme in a realistic, humorous, poetic, etc. way.

1.2 Duration

The contest runs from August 1st, 2020 at 00:01 a.m to October 1st, 2020 at 23:59 p.m according to the terms of these rules.

The results of the competition will be announced at the end of October 2020.

The organizers reserve the right, in case of force majeure or for any reason beyond their control, to modify the dates, cancel or interrupt the contest. Their responsibility can not be engaged as a result.

1.3 Participants

The competition is open to any individual belonging to the International Red Cross and Red Crescent Movement.

All persons who have participated in the preparation of this competition are excluded.

ART 2. TERMS AND CONDITIONS OF PARTICIPATION

2.1. The photos must have a link to the work of the French Red Cross/PIROI.

2.2. Photos must be in high definition with a minimum weight of 2 MB. However, we invite you to compete with pictures of the highest possible quality, 5 MB and more.

2.3. A participant may submit several photos.

2.4. In order to be able to compete, the participant must fill in the registration form with the following information:

- Name

- First name
- Position / National Society
- E-mail address and telephone number
- Photo title
- Place, date and context of the photograph
- The exact weight of your photo in HD

The sending of this form constitutes acceptance of these regulations.

The form is attached to the regulations and can also be downloaded on PIROI's website.

Any transmission by a participant of incorrect, incomplete or inaccurate information may lead to the exclusion of the participant.

2.5. The photos, together with the completed registration form, are sent by email to the following address: piroi.assist-com@croix-rouge.fr

2.6. Photos sent by email must be original (2 MB or more) and titled in jpeg format.

2.7. Photos submitted anonymously or accompanied by an incomplete registration form will not be accepted.

2.8 The organizers cannot be held responsible for delays or losses of shipments, or for their destruction in any other accidental case.

ART. 3. DESIGNATION OF THE WINNERS

The winners will be selected at the end of the competition by a jury composed of members of the French Red Cross and photographers.

The jury will select the winning photographs according to their artistic and technical qualities, their originality and respect for the theme.

The jury is sovereign and may, until the official decision to publish, make any changes to the outcome of the deliberation, particularly in cases where the photos are tainted with counterfeit or plagiarism, but also if the photos are not free of rights, or too close to a photo already published or disseminated.

ART 4. WINNERS

4.1. Winners will be informed by email and/or telephone of the outcome of the jury's deliberations.

4.2. The winning photos will be displayed on the walls of the PIROI and will be used on PIROI's communication tools.

ART. 5. PRIZES

- 5.1. The nature of the prizes will be announced later on the PIROI's site and social networks.
- 5.2. The winners of the contest will have to collect their prize at the headquarters of the PIROI, in Sainte-Marie, La Réunion, or at the headquarters of the National Society to which they belong, subject to an additional period of time, if it is possible.
- 5.3. No prize may be exchanged for another prize or its cash value for any reason whatsoever.
- 5.4. For the winners who were unable to make the trip, the prize will be awarded by post or by a member of the PIROI/French Red Cross.
It is further understood that if the advertised lot cannot be delivered, for reasons beyond the control of the organizers or in the event of non-supply of the lots by our partner, the organizers cannot be held responsible. No consideration or financial equivalent may be claimed by the participant.
- 5.5. In the event that it is not possible for them to provide the original prize, the organizers reserve the right to replace the prize with another prize. They may then, if necessary, modify the conditions of availability.

ART. 6. WARRANTIES AND RESPONSIBILITIES

- 6.1. The participants guarantee on their honour that they are the copyright holders of each of the photos proposed to the jury. They acknowledge that they have taken each of the photographs themselves and authorize their free representation in a real exhibition, on the website or other tools of the French Red Cross or in any other publication of the French Red Cross or one of the components of the International Red Cross and Red Crescent Movement.
- 6.2. If the author presents a photo with one or more recognizable persons, he must have obtained prior permission to reproduce and use their image, and if the subject is a minor, parental permission. (model authorization forms will be attached to this document).
- 6.3. Each participant undertakes to have the full capacity to dispose of the rights he/she has over the contents of the contest and in particular to ensure that the photo he/she sends has not been published in advance, nor to have a forthcoming publishing contract and not to have been directly or indirectly inspired by a previously published photo.
- 6.4. If the author presents a photograph showing an identifiable trademark, logo or other proprietary material, he/she must have obtained prior permission to use, reproduce and exploit this element.
- 6.5. The organizers reserve the right to remove a photo, without having to justify their decision, if they consider that the content provided by the participant can be considered as: contrary to the principles and values of the Red Cross and Red Crescent Movement; undermining the dignity and respect of others; devaluing for the organizers and thus contrary to their material and/or moral interests; which may infringe French and Community legislation.

ART. 7. RIGHT ASSIGNMENTS

By the mere fact of accepting these rules, the participants authorize the organizers to use their names, surnames and pseudonyms and to use their photographs and titles for all types of exploitation, both current and future, on all media, without any limitation of space and for the duration of the literary

and artistic property on the work, according to French and foreign legislation and current or future international conventions, including any extensions that may be made This use may not in any case give rise to any right to any remuneration or other service.

ART. 8. ACCEPTANCE AND AMENDMENT OF THE REGULATIONS

Participation in this contest implies the pure and simple acceptance of the participants of these rules and the rules of conduct on the Internet as well as the laws and regulations applicable to the contests, without any possibility of claiming as to the results.
